CONTACT AT GIA DANG III (YD4360)

1. ORGANIZATION

- A. MANEUVER ELEMENTS: A AND B CO, 1ST BATTALION 8TH CAVALRY.
- B. FIRE SUPPORT

2. CONCEPT OF OPERATION: TO EXPLOIT INTELLIGENCE INDICATING PRESENCE OF AN NVA BATTALION AND POSSIBLY A REDIMENTAL CP AT GIA DANG III (YD4360), A TEMPORARY FIRE BASE WAS ESTABLISHED AND A TWO COMPANY COORDINATED AIRMOBILE RECONNAISSANCE IN FORCE WAS PLANNED AND EXECUTED ON 16 FEBRUARY. THE RECONNAISSANCE IN FORCE WAS SUBSEQUENTLY FOLLOWED BY A TWO COMPANY COORDINATED ATTACK ON 17 FEBRUARY.

A. ESTABLISHMENT OF THE FIRE BASE: AT 160601 FEBRUARY C CO MOVED BY LAND FROM A LOCATION AT YD405544 TO A LOCATION AT YD392544 TO PROVIDE FIRE BASE SECURITY FOR A BATTERY, 2ND BATTALION 19TH ARTILLERY. THE COMPANY CLOSED AND SECURED THE NEW BASE BY 0705H. DURING A DETAILED SEARCH OF THE SECURED AREA, C CO FOUND 3 CHI CON LMGs, 4SKS CARBINES, 1 AK47 AND 3 ROCKET LAUNCHERS. A BATTERY'S AIR MOVE BY CH47 WAS CONDUCTED BY 0900H, AND THE BATTERY WAS LAID AND READY TO FIRE BY 0930H.

B. AIRMOBILE RECONNAISSANCE IN FORCE: A AND B COS, 1ST BATTALION 8TH CAVALRY WERE COMBAT ASSAULTED AT 1000H AND 1042H RESPECTIVELY. ALTHOUGH BOTH LZ'S WERE GREEN, ARA RECEIVED FIRE AND SUSTAINED ONE CASUALTY OVER GIA DANG III, ONE KILOMETER TO THE NORTH OF THE LZ. IMMEDIATE RECONNAISSANCE OF THAT AREA BY SCOUT SHIPS REVEALED NO ENEMY LOCATIONS. A AND B COS LINKED UP, DISPOSED ABREAST AND SWEEP THROUGH GIA DANG II TO THE NE. NEGATIVE ENEMY SIGHTINGS WERE MADE. AT THIS JUNCTURE, SCOUT SHIPS WERE

CALLED BACK ON STATION TO ASSESS FURTHER ENEMY ACTIVITY IN THE AREA. AT 1203H THE SCOUTS REPORTED SIGHTING ONE ACTIVE ENEMY BUNKER AT GIA DANG III. THE BATTALION COMMAND AND CONTROL SHIP PROCEEDED ON STATION, AND THE ARTILLERY LIAISON OFFICER CALLED IN 180 MIXED 105MM AND 8 INCH ARTILLERY ROUNDS. B CO WAS COMMITTED ALONG THE COAST TO THE NW TO ASSESS THE ARTILLERY CONCENTRATIONS AND CONTINUE THE RECONNAISSANCE MISSION. AT 1410H LEAD SECURITY ELEMENTS ADVANCED TO WITHIN 50 METERS OF THE BUNKER COMPLEX AND CAME UNDER INTENSE AUTOMATIC WEAPONS FIRE. THE ELEMENT IMMEDIATELY SUSTAINED NINE CASUALTIES AND THE ENTIRE COMPANY WAS PINNED DOWN. TUBE ARTILLERY WAS AGAIN CALLED INTO THE AREA AND ARA CALLED ON STATION. TUBE ARTILLERY WAS LIFTED AND ARA WAS CALLED IN AGAINST THE WELL DEFINED, LINEAR BUNKER COMPLEX. ON LONG FINAL, THE ARA SHIP RECEIVED HEAVY ANTI-AIRCRAFT (.50 CAL) FIRE, SUSTAINED ONE CASUALTY AND WAS REQUIRED TO BREAK FOR MED-EVAC. SUSTAINED TUBE ARTILLERY WAS ADJUSTED TO WITHIN 50 METERS OF FRIENDLY POSITIONS, AND INITIAL EXTRACTION OF THE SECURITY ELEMENTS COMMENCED. THESE EFFORTS WERE DETERRED BY ENEMY 60MM MORTAR FIRE. A CO, COMMITTED TO B CO'S LEFT FLANK, BROUGHT A^M AND M79 FIRE ON SUSPECTED ENEMY MORTAR LOCATIONS. THIS MANEUVER SUPPORTED BY ADDITIONAL TUBE ARTILLERY SILENCED THE ENEMY MORTARS AND ALLOWED THE FINAL EXTRACTION OF THE PINNED DOWN ELEMENTS. A PZ ALREADY PREPARED AND SECURED DURING A CO'S FLANKING MANEUVER, ACCOMMODATED IMMEDIATE EVACUATION OF THE WOUNDED AND A RESUPPLY OF AMMUNITION. ONE AIR STRIKE AND ADDITIONAL TUBE ARTILLERY WAS PLACED IN THE CONTACT AREA AS A AND B COS REDEPLOYED INTO A NIGHT DEFENSIVE PERIMETER. HEAVY H&I FIRES, TO HOLD THE ENEMY IN PLACE, WERE CONCENTRATED IN THE AREA DURING THE NIGHT OF 16 FEBRUARY.

ON 171000H FEBRUARY, UNDER THE PROTECTIVE UMBRELLA OF TWO ARA GS CONCENTRATIONS, SANDWICHED BETWEEN TWO 10 MINUTE ARTILLERY AND NAVAL GUN TOT'S, A AND B COMPANIES DEPLOYED ABREAST AND JUMPED OFF IN THE ATTACK. WITHIN TWO HOURS GIA DANG III WAS SECURED WITHOUT RESISTANCE. POLICE OF THE BATTLE AREA TURNED UP 20 ENEMY DEAD, 3SKS RIFLES, 3AK 47 RIFLES, 1 RPD IMC, 1 60MM MORTAR TUBE; RIFLE, MACHINE GUN AND MORTAR ROUNDS; AND ASSORTED MILITARY EQUIPMENT AND MEDICAL SUPPLIES. DURING THE ACTION, 1ST BDE SCOUTS REPORTED DESTROYING ONE .50 CAL. HMG, AND THE 1/9TH SCOUTS REPORTED OBSERVING ONE OTHER .50 CAL. HMG THAT HAD BEEN DESTROYED.

2. CONCEPT OF OPERATION: C Co, WHILE STILL DEPLOYED IN DEFENSIVE POSTURE AT XA DONG (YD392544) (SEE INCL 1), WAS ATTACKED BY AN ESTIMATED NVA BN ON 180107 FEB. THE ATTACK HAD BEEN FORECASTED BY AN INTELLIGENCE REPORT RECEIVED DURING THE EARLY EVENING 17 FEB, AND THE COMPANY ACCORDINGLY STIFFENED THEIR DEFENSES AND COMMITTED ADDITIONAL OP'S. THE ATTACK, SCHEDULED FOR 0200, WAS TRIGGERED PREMATURELY AT 0107 BY AN OP VIC YD392544. THE COMPANY, DIRECTED BY THE BN CO TO BE ON 100% ALERT AS OF 0100, IMMEDIATELY RESPONDED WITH OVERWHELMING ORGANIC AND INORGANIC FIRES, PULLING IN THE COMPROMISED OP. THE 40 NVA TROOPS, COMPRISING THE ENEMY'S INITIAL GROUND ATTACK ECHELON, WAS SENT REELING BACK IN DISORDER. AT 0130 HEAVY ENEMY MORTAR AND B40 ROCKETS SATURATED THE COMPANY'S DEFENSIVE AREA. INCLEMENT WEATHER PRECLUDING USE OF ARA. THREE ARTILLERY BATTERIES MASSES FIRES ON SUSPECTED ENEMY LOCATIONS. ENEMY FIRES WERE TEMPORARILY SUSPENDED, RESUMING AGAIN AT 0152 HOURS. THESE ENEMY FIRES WERE COMPLEMENTED WITH TWO GROUND ATTACKS FROM THE WEST AND NORTHWEST OF THE PERIMETER. AT THIS JUNCTURE, THE COMPANY FIRED ITS FINAL PROTECTIVE FIRES, AND ALL 3 SUPPORTING BATTERIES FIRED AN AWESOME BARRIER OF STEEL AROUND THE COMPANY'S POSITION. PLASTER FROM BUILDINGS WITHIN THE PERIMETER, CHIPPED BY FRIENDLY FIRES, RAINED DOWN ON THE DEFENDERS' HEADS. EASILY THE TURNING POINT OF THE ATTACK, THE NVA ELEMENTS WERE AGAIN SENT REELING BACK INTO PROTECTIVE IRRIGATION DIKES 100 TO 200 METERS FROM THE PERIMETER. MEDEVAC AND RESUPPLY MISSIONS WERE ACCOMPLISHED UNDER SPORATIC AW FIRE, AS THE COMPANY REORGANIZED AND CONSOLIDATED ITS POSITION, PREPARING FOR THE NEXT ATTACK. IT DID NOT COME! ALTHOUGH MOUNTING SEVERAL MORE SPORATIC AND INEFFECTIVE ROCKETS AND MORTAR ATTACKS AND ONE ADDITIONAL GROUND PROBE FROM THE EAST, THE ENEMY'S BACK WAS BROKEN, AND HE RETREATED, DRAGGING HIS DEAD AND WOUNDED WITH HIM. POLICE OF THE BATTLE AREA THE NEXT DAY REVEALED 8 NVA KIA, 6 AK47'S, NUMEROUS SATCHEL CHARGES, 35 GRENADES, LARGE QUANTITIES OF B40 RL, AK AND IMG AMMUNITION, MEDICAL SUPPLIES, AND ASSORTED NVA EQUIPMENT. NUMEROUS BLOOD POOLS AND DRAG MARKS INDICATED LARGE NUMBERS OF NVA KIA HAD BEEN SUCCESSFULLY CARRIED

AWAY. SHALLOW GRAVES DISCOVERED IN THE FOLLOWING WEEK VERIFIED THIS INDICATION. OF CURIOUS NOTE, ONE OF THE NVA KIA WAS FOUND IN A SITTING POSITION, NOTEBOOK AND PENCIL IN HAND. DOCUMENT READOUTS INDICATED THAT THIS INDIVIDUAL WAS THE COMPANY COMMANDER OF ONE OF THE ATTACKING INFANTRY ELEMENTS, AND HE HAD BEEN TAKING NOTES OF THE BATTLE FROM A POSITION WITHIN 20 METERS OF THE DEFENSIVE PERIMETER.

For heroism in connection with military operations against a hostile force in the Republic of Vietnam. Specialist Four Bowman distinguished himself by heroism in action on 16 February 1968, while serving as a rifleman with Company B, 1st Battalion (Airborne), 8th Cavalry during a combat mission in Quang Tri Province, Republic of Vietnam. When his unit became heavily engaged with a large enemy force, Specialist Bowman volunteered to move forward as a radio-telephone operator. Disregarding his own safety, Specialist Bowman continually exposed himself to the hostile fire to insure that communications were maintained within his unit. His display of personal bravery and devotion to duty is in keeping with the highest traditions of the military service, and reflects great credit upon himself, his unit, and the United States Army.

P R O P O S E D C I T A T I O N

FOR GALLANTRY IN ACTION WHILE ENGAGED IN MILITARY OPERATIONS AGAINST AN ARMED HOSTILE FORCE. PRIVATE FIRST CLASS SORENSON DISTINGUISHED HIMSELF ON 16 FEBRUARY 1968 WHILE SERVING AS A MACHINGUNNER DURING OPERATIONS IN QUANG TRI PROVINCE. AS HIS UNIT WAS ADVANCING TOWARD A SERIES OF WELL DUB IN HOSTILE POSITIONS IT CAME UNDER INTENSE AUTOMATIC WEAPONS FIRE. ACTING IMMEDIATELY, PRIVATE FIRST CLASS SORENSON BEGAN TO RETURN THE FIRE. ALTHOUGH HE IMMEDIATELY CAME UNDER EXTREMELY HEAVY FIRE HE CONTINUED TO STAND HIS GROUND AND PLACED HIS FIRE SO EFFECTIVELY THAT HIS UNIT WAS ABLE TO ADVANCE AND SECURE THE FLANK. IN THE PERFORMANCE OF THIS ACTION HE WAS STRUCK AND MORTALLY WOUNDED BY THE ENEMY FIRE. HIS HEROIC ACTION WAS AN INSPIRATION TO HIS ENTIRE UNIT AND CONTRIBUTED GREATLY TO THE SUCCESS OF HIS UNIT'S MISSION. HIS COURAGE AND STEADFAST DEVOTION TO DUTY AT THE COST OF HIS OWN LIFE STAND IN KEEPINC WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

P R O P O S E D C I T A T I O N

FOR HEROISM, NOT INVOLVING PARTICIPATION IN AERIAL FLIGHT, IN CONNECTION WITH MILITARY OPERATIONS AGAINST A HOSTILE FORCE. SPECIALIST HALL DISTINGUISHED HIMSELF ON 16 FEBRUARY 1968 WHILE SERVING AS A SQUAD LEADER DURING OPERATIONS NEAR THON GIA DONG. DURING ACTION AGAINST A WELL DUG IN NORTH VIETNAMESE COMPANY IT WAS THE MISSION OF SPECIALIST HALL'S SQUAD TO PROVIDE FIRE SUPPORT FOR A PINNED DOWN PLATOON AND ALSO TO MARK THE RIGHT FLANK OF THE COMPANY'S POSITION WITH SMOKE GRENADES TO ALLOW ARTILLERY AND AERIAL ROCKET ARTILLERY TO STRIKE AT THE ENEMY POSITIONS WITHOUT HITTING THE FRIENDLY FORCES. HE LED HIS SQUAD ACROSS AN OPEN BEACH AREA UNDER HEAVY FIRE TO ITS ASSIGNED POSITION. WHEN THE SUPPLY OF SMOKE GRENADES RAN OUT SPECIALIST HALL, REALIZING THE VITAL IMPORTANCE OF HIS MISSION, UNHESITATINGLY, AND WITHOUT REGARD FOR HIS PERSONAL SAFETY, RAN BACK ACROSS THE BEACH UNDER HEAVY FIRE TO GET A RESUPPLY OF SMOKE GRENADES. AFTER DOING THIS HE AGAIN BRAVED THE HOSTILE FIRE TO RETURN TO HIS POSITION. HIS COURAGEOUS ACTION WAS INSTRUMENTAL IN SAVING FRIENDLY LIVES AND CONTRIBUTED GREATLY TO THE SUCCESS OF THE MISSION. SPECIALIST HALL'S HEROIC ACTIONS STAND IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

P R O P O S E D C I T A T I O N

FOR HEROISM, NOT INVOLVING PARTICIPATION IN AERIAL FLIGHT, IN CONNECTION WITH MILITARY OPERATIONS AGAINST A HOSTILE FORCE, SERGEANT PINCURA DISTINGUISHED HIMSELF ON 16 FEBRUARY 1968 WHILE SERVING AS A SQUAD LEADER DURING OPERATIONS NEAR THON GIA DONG. AS HIS UNIT WAS MOVING THROUGH A WOODED AREA IT CAME UNDER INTENSE FIRE FROM A FORCE OF WELL ENTRENCHED NORTH VIETNAMESE REGULARS. IN THE INITIAL STAGE OF THE ACTION SERGEANT PINCURA'S PLATOON LEADER WAS FATALLY WOUNDED, LEAVING HIM IN CHARGE OF THE PLATOON. IMMEDIATELY TAKING CHARGE, SERGEANT PINCURA REALIZED THE NECESSITY OF POSITIONING HIS MEN AND PROVIDING COVER FOR THE EVACUATION OF THE CASUALTIES. WITHOUT REGARD FOR HIS OWN SAFETY HE BRAVED THE HOSTILE FIRE TO PLACE HIS MEN AT STRATEGIC POSITIONS TO PROVIDE COVER FOR THE WOUNDED. FREQUENTLY EXPOSING HIMSELF COMPLETELY TO THE HOSTILE FIRE, HE MANEUVERED HIS MEN AND THEN TOOK UP A POSITION HIMSELF. HIS DETERMINED LEADERSHIP AND PERSONAL FORTITUDE WERE RESPONSIBLE FOR THE SMOOTH EVACUATION OF THE WOUNDED. HIS HEROIC ACTS STAND IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

P R O P O S E D C I T A T I O N

FOR HEROISM, NOT INVOLVING PARTICIPATION IN AERIAL FLIGHT, IN CONNECTION WITH MILITARY OPERATIONS AGAINST A HOSTILE FORCE. SERGEANT CHAMPINE DISTINGUISHED HIMSELF ON 16 FEBRUARY 1968 WHILE SERVING AS A SQUAD LEADER DURING OPERATIONS IN QUANG TRI PROVINCE. AS HIS UNIT WAS MOVING THROUGH A SMALL VILLAGE IT CAME UNDER HEAVY ENEMY FIRE. THE PLATOON LEADER OF SERGEANT CHAMPINE'S PLATOON WAS MORTALLY WOUNDED IN THE INITIAL STAGE OF THE CONFLICT, LEAVING HIM IN COMMAND. IMMEDIATELY TAKING OVER THE DISORGANIZED PLATOON HE MANEUVERED THEM SKILLFULLY AND SET UP A BASE OF FIRE AGAINST THE HOSTILE POSITIONS. NEXT, REALIZING THAT THERE WERE WOUNDED MEMBERS OF HIS UNIT STILL EXPOSED TO THE HOSTILE FIRE, HE PERSONALLY MOVED FORWARD TO ASSIST THEM. UNDER ENEMY FIRE HE COMPLETELY DISREGARDED HIS PERSONAL SAFETY AND MADE SEVERAL TRIPS TO THE FOREMOST ELEMENT TO ASSIST THE WOUNDED AND HELP THEM TO THE REAR FOR EVACUATION. SERGEANT CHAMPINE'S OUTSTANDING LEADERSHIP AND PERSONAL COURAGE WAS RESPONSIBLE FOR MAINTAINING THE EFFECTIVENESS OF HIS UNIT AND SAVED THE LIVES OF SEVERAL OF HIS COMRADES. HIS HEROIC ACTIONS WERE IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

P R O P O S E D C I T A T I O N

FOR GALLANTRY IN ACTION WHILE ENGAGED IN MILITARY OPERATIONS AGAINST AN ARMED HOSTILE FORCE. STAFF SERGEANT MORRIS DISTINGUISHED HIMSELF ON 16 FEBRUARY 1968 WHILE SERVING AS A PLATOON SERGEANT DURING OPERATIONS IN QUANG TRI PROVINCE. AS HE WAS LEADING HIS PLATOON TOWARD A SERIES OF WELL DUC IN HOSTILE POSITIONS, STAFF SERGEANT MORRIS' UNIT CAME UNDER INTENSE ENEMY AUTOMATIC WEAPONS FIRE. MOST OF THE MEN IN HIS PLATOON CONVERGED TOWARD THE LEFT TO TAKE COVER. NOTING THIS, HE IMMEDIATELY SENT A SQUAD TO PROVIDE SECURITY ON THE RIGHT FLANK. AS THE SQUAD MOVED OUT THREE OF THE MEN WERE WOUNDED BY THE ENEMY FIRE. AT THIS TIME, WITH UTTER DISREGARD FOR HIS PERSONAL SAFETY, STAFF SERGEANT MORRIS RAN TOWARD THE POSITION OF THE WOUNDED MEN IN AN ATTEMPT TO PROVIDE COVERING FIRE. AS HE DID SO HE WAS STRUCK AND MORTALLY WOUNDED BY THE ENEMY FIRE. HIS COURAGEOUS ACTION SERVED AS AN INSPIRATION TO THE REST OF HIS UNIT AND SUBSEQUENTLY MORE OF HIS COMRADES BRAVED THE HOSTILE FIRE AND RECOVERED THE BODIES OF THE WOUNDED MEN. STAFF SERGEANT MORRIS' HEROIC ACTION, PERFORMED AT THE COST OF HIS OWN LIFE, STANDS IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECTS GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

ON THE NIGHT OF THAT DATE SERGEANT MC COLLUM'S COMPANY CAME UNDER AN INTENSE ATTACK BY ROCKETS AND MORTAR ROUNDS. DURING THE ATTACK HE CONTINUALLY LEFT HIMSELF COMPLETELY EXPOSED TO THE HOSTILE FIRE AS HE LEFT HIS OWN POSITION TO CHECK THE POSITIONS OF THE MEN IN HIS SQUAD. DURING ONE PARTICULARLY CRUCIAL PHASE OF THE ENEMY ATTACK ONE OF THE MACHINEGUNS ATTACHED TO HIS SQUAD CEASED TO FIRE. WITH COMPLETE DISREGARD FOR HIS PERSONAL SAFETY HE RAN ACROSS AN OPEN AREA TO THE MACHINEGUN POSITION UNDER INTENSE ENEMY FIRE AND GOT IN BACK INTO THE ACTION. WHILE RETURNING TO HIS OWN POSITION HE RECEIVED WOUNDS FROM AN ENEMY ROCKET THAT ULTIMATELY PROVED FATAL. HIS HEROIC ACTION WAS OF IMMEASURABLE VALUE TO THE SUCCESSFUL DEFENSE OF HIS COMPANY'S POSITION. SERGEANT MC COLLUM'S COURAGE AND STEADFAST DEVOTION TO DUTY AT THE COST OF HIS OWN LIFE STAND IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

P R O P O S E D C I T A T I O N

FOR HEROISM, NOT INVOLVING PARTICIPATION IN AERIAL FLIGHT, IN CONNECTION WITH MILITARY OPERATIONS AGAINST A HOSTILE FORCE, PRIVATE FIRST CLASS TURNBULL DISTINGUISHED HIMSELF ON 18 FEBRUARY 1968 WHILE SERVING AS A RECOILLESS RIFLEMAN DURING OPERATIONS IN QUANG TRI PROVINCE. PRIVATE FIRST CLASS TURNBULL'S COMPANY CAME UNDER AN INTENSE ENEMY ROCKET AND MORTAR ATTACK WHILE HE WAS MANNING A 90MM RECOILLESS RIFLE. IMMEDIATELY HE BEGAN TO RETURN FIRE AT THE HOSTILE POSITIONS. PRIVATE FIRST CLASS TURNBULL CONTINUALLY EXPOSED HIMSELF TO THE ENEMY IN ORDER TO POINT OUT ENEMY POSITIONS. WHEN AMMUNITION RAN LOW HE LEFT HIS POSITION AND RAN ACROSS AN OPEN AREA TO SECURE A RESUPPLY. WITH COMPLETE DISREGARD FOR HIS PERSONAL SAFETY HE EXPOSED HIMSELF TO THE INTENSE HOSTILE FIRE AND BROUGHT BACK THE MUCH NEEDED AMMUNITION. SHORTLY THEREAFTER HIS POSITION WAS HIT BY AN ENEMY ROCKET ROUND AND HE WAS FATALLY WOUNDED. HIS COURAGEOUS ACTIONS WERE INVALUABLE FACTORS IN THE DEFENSE OF THE FRIENDLY POSITION, ALLOWING THE ENEMY ATTACK TO BE REPELLED EVEN AT THE COST OF HIS OWN LIFE. HIS HEROISM AND STEADFAST DEVOTION TO DUTY STAND IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

FOR GALLANTRY IN ACTION WHILE ENGAGED IN MILITARY OPERATIONS AGAINST AN ARMED HOSTILE FORCE. FIRST SERGEANT FISHER DISTINGUISHED HIMSELF ON 18 FEBRUARY 1968 WHILE SERVING AS A FIRST SERGEANT DURING OPERATIONS IN QUANG TRI PROVINCE. DURING THE EARLY MORNING HOURS OF THAT DATE FIRST SERGEANT FISHER'S COMPANY CAME UNDER AN INTENSE ROCKET AND MORTAR ATTACK BY AN ESTIMATED TWO BATTALION SIZE FORCE OF NORTH VIETNAMESE REGULARS. DURING THIS ATTACK AND THE SUBSEQUENT GROUND ATTACK FIRST SERGEANT FISHER CONTINUALLY EXPOSED HIMSELF TO THE INTENSE ENEMY FIRE TO MOVE SEVERAL WOUNDED MEN TO SAFETY. HE AGAIN EXPOSED HIMSELF WITHOUT REGARD FOR HIS PERSONAL SAFETY TO PERSONALLY SUPERVISE THE EVACUATION OF THE WOUNDED. WHEN AN EMERGENCY RESUPPLY OF AMMUNITION CAME IN HE ONCE MORE EXPOSED HIMSELF TO THE ENEMY TO PERSONALLY UNLOAD AND DISTRIBUTE THE AMMUNITION. DURING THE HOSTILE GROUND ATTACK HE CHOSE TO LEAVE THE RELATIVE SECURITY OF THE COMPANY COMMAND POST IN ORDER TO ASSIST THE LEADERS OF AN ENBATTLED PLATOON. THROUGHOUT THE ACTION HIS COURAGEOUS ACTS WERE AN INSPIRATION TO THE MEN OF HIS UNIT AND CONTRIBUTED GREATLY TO THE SUCCESSFUL REPULSION OF THE HOSTILE ATTACK. HIS PERSONAL COURAGE, OUTSTANDING LEADERSHIP AND STEADFAST DEVOTION TO DUTY STAND IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

FOR GALLANTRY IN ACTION WHILE ENGAGED IN MILITARY OPERATIONS AGAINST AN ARMED HOSTILE FORCE. LIEUTENANT PARRAMORE DISTINGUISHED HIMSELF ON 18 FEBRUARY 1968 WHILE SERVING AS AN ARTILLERY FORWARD OBSERVER DURING OPERATIONS IN QUANG TRI PROVINCE. ON THAT DATE LIEUTENANT PARRAMORE'S UNIT CAME UNDER A SAVAGE MORTAR AND ROCKET ATTACK BY A LARGE FORCE OF NORTH VIETNAMESE REGULARS. DURING THE EARLY MOMENTS OF THE INTENSE ATTACK, LIEUTENANT PARRAMORE EXPOSED HIMSELF COMPLETELY TO THE HOSTILE ROCKET AND MORTAR FIRE IN ORDER TO CALL IN AND ADJUST ARTILLERY FIRE ON THE ENEMY POSITIONS. DURING A SUBSEQUENT GROUND ATTACK HE CONTINUED TO EXPOSE HIMSELF WITHOUT REGARD FOR HIS PERSONAL SAFETY TO ADJUST FIRE ON THE ADVANCING ENEMY FORCES. MANY OTHER SMALLER PROBES WERE ALSO REPULSED BY HIS TIMELY AND ACCURATE ADJUSTMENT OF ARTILLERY FIRE. LIEUTENANT PARRAMORE'S PERSONAL COURAGE WAS THE DECIDING FACTOR IN THE SUCCESSFUL REPULSE OF THE HOSTILE ATTACK. HIS HEROIC ACTIONS AND PROFESSIONAL COMPETANCE STAND IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.

FOR HEROISM, NOT INVOLVING PARTICIPATION, IN AERIAL FLIGHT, IN CONNECTION WITH MILITARY OPERATIONS AGAINST A HOSTILE FORCE. SERGEANT SLEE DISTINGUISHED HIMSELF ON 18 FEBRUARY 1969 WHILE SERVING AS A SQUAD LEADER DURING A MILITARY OPERATION IN QUANG TRI PROVINCE. EARLY IN THE MORNING OF THAT DAY SERGEANT SLEE'S COMPANY CAME UNDER AN INTENSE ENEMY ROCKET AND MORTAR ATTACK. AS HIS PLATOON'S WEAPON SQUAD LOADED, SERGEANT SLEE IMMEDIATELY DIRECTED FIRE AGAINST THE ENEMY POSITIONS. WITHOUT REGARD FOR HIS PERSONAL SAFETY HE COMPLETELY EXPOSED HIMSELF TO THE ENEMY FIRE BY RUNNING FROM POSITION TO POSITION TO DIRECT THE FIRE AGAINST THE ENEMY. WHEN AN ENEMY ROCKET ATTACK INTENSIFIED AND HIS OWN POSITION CAME UNDER AN INTENSE ROCKET ATTACK HE AGAIN EXPOSED HIMSELF TO THE ENEMY TO DESTROY THE ENEMY ROCKET POSITION WITH RECOILLESS RIFLE FIRE AND GRENADES. THROUGH HIS PERSONAL COURAGE AND SKILLFUL LEADERSHIP, AN IMPORTANT ENEMY POSITION WAS DESTROYED AND MANY LIVES SAVED. HIS HEROIC ACTS STAND IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MILITARY SERVICE AND REFLECT GREAT CREDIT UPON HIMSELF, HIS UNIT, AND THE UNITED STATES ARMY.
